

Adding CE Mark on Batteries for AC Servo Amplifiers in Compliance with EU Battery Regulation

Thank you for your continued patronage of the Mitsubishi Electric AC servo system. For battery products for the AC servo amplifiers, built-in batteries will bear the CE mark to comply with the requirements of the EU Battery Regulation (REGULATION (EU) 2023/1542) newly issued by the European Commission, which will be launched on August 18, 2024.

1. Target Model

MR-BAT6V1SET(-□) (*1), MR-BAT6V1, MR-BAT6V1BJ, MR-BAT, MR-J3BAT, MR-J3W03BATSET, MR-J2M-BT(-□) (*2), MR-JBAT4, and MR-JBAT8

*1. The symbol "□" indicates a blank or an alphanumeric character. (Example: A)

*2. The symbol "□" indicates a blank or two alphanumeric characters. (Example: EB)

2. Reason for the Change

To comply with the EU Battery Regulation



3. Details of the Change

Built-in batteries will bear the CE mark.





In terms of the restrictions on substances in the EU Battery Regulation, the substances contained in the batteries have been all under the regulated values.

The components of the batteries are the same before and after the change.

This change will only involve the bearing of the CE mark and does not affect the functions and performance of the products.

4. Schedule

- (1) MR-BAT6V1SET(-□), MR-BAT6V1, MR-BAT6V1BJ
This change will be made sequentially from the June 2024 production.
- (2) MR-BAT, MR-J3BAT, MR-J3W03BATSET, MR-J2M-BT(-□), MR-JBAT4, MR-JBAT8
This change will be made sequentially from the July 2024 production.

There may be cases where both the former and new products exist in the distribution stage.

5. For Customers Exporting to EU Member States

It is necessary to comply with the EU Battery Regulation when launching products onto the market of EU member states from August 18, 2024.

When exporting batteries or products containing batteries to EU member states, customers (importers in the EU) may be required to comply with the EU Battery Regulation, such as manufacturer registration, importer obligations, etc.

When exporting products not complying with the EU Battery Regulation to EU member states, please contact your local sales office. Replacement with batteries bearing the CE mark or documentation such as Declaration of Conformity will be required.
